**Brief Description or Justification:**

**Form – 1A**

Re-roofing of Student Center

The Student Center which was constructed in 1986 is approximately 2500 square feet under roof consisting of 2 offices and a student lounge/break area with vending machines. This facility has a metal roof with a slight slope and 4 “gutter system along the back wall. The roof leaks during severe weather events and has to be maintained on a regular basis.

The College will continue to make temporary repairs to the roof until funds become available to replace. The cost to replace the roof system with new metal and to replace the gutter system with an 8” drain is expected to be approximately \$75,000.00.

**Form – 1B**

Erosion/Drainage Project

Reid State Technical College began operation in 1966. Streets and parking lots were constructed without putting in place the proper underground storm drains, retainer walls or flumes to carry excessive rainwater from areas on campus to their perspective place without the threat of deteriorating asphalt streets and parking lots or causing erosion issues on unpaved landscapes. The streets, parking lots and truck driver training track on the Evergreen campus have recently been resurfaced and/or seal-coated and striped to repair deteriorated surfaces. In order to secure these surfaces for long term it is imperative that storm drain boxes be installed to get standing water off streets and parking lots, to repair the retainer wall on back of parking lot behind building 600 and to safeguard the embankments around the truck driver training track to prevent further erosion. The cost of this project is estimated to be \$\$250,000.00.

Renovation/Expansion of Student Center

The current student center has inadequate space to accommodate the number of students on campus at Reid State Technical College. It has no restroom facilities or wash-rooms. With the continued increase in enrollment at Reid State, it is imperative that the center be renovated and expanded to accommodate and meet the needs of all students as well as improve campus life for the students. The Student Center is currently 2500 square feet and after expansion it would be increased to no less than 5000 square feet. The estimated cost to expand and renovate the Student Center is \$500,000.00.

Construction of Maintenance Building

The College is in need of a serviceable maintenance building. The maintenance staff does not have a central point on campus to operate from. The proposed maintenance building would include an office, restroom, small storage area, and a workshop. Currently the maintenance staff works out of various closets and small storage areas located throughout the campus. The estimated cost of this project is \$150,000.00.
